

## The Guild

- **promotes** prayer & care for the sick, dying, departed and bereaved,
- **holds** day conferences,
- **produces** prayer cards and booklets,
- **publishes** a website with further resources, the full chantry list of departed members, and links to bereavement helplines & organisations,
- **is** patron of various parishes,
- **hosts** an annual Requiem in St Stephen, Gloucester Road, Kensington, where Requiems are also offered twice monthly,
- **arranges** an annual Mass in West Tofts in Norfolk's STANTA area.

## Members

- **receive** the intercession paper containing names of those who have died in the past 15 years. (Names of non-members can be added; ask the General Secretary for details)
- **will be remembered** in perpetuity on the anniversary of their death

## and are encouraged to

- **pray and care for** the sick, dying, departed and bereaved,
- **pray** at least weekly for those who have died in the past 15 years,
- **attend** Requiem Masses, particularly on All Souls' Day.

## Priest members and Guild Branches

- **are asked** to celebrate a monthly Requiem.

The Guild's Chantry Chapel of St Michael and the Holy Souls is in the grounds of the Anglican Shrine of Our Lady of Walsingham, Norfolk.



Mass is offered daily.  
All departed members are remembered on the anniversary of their death.

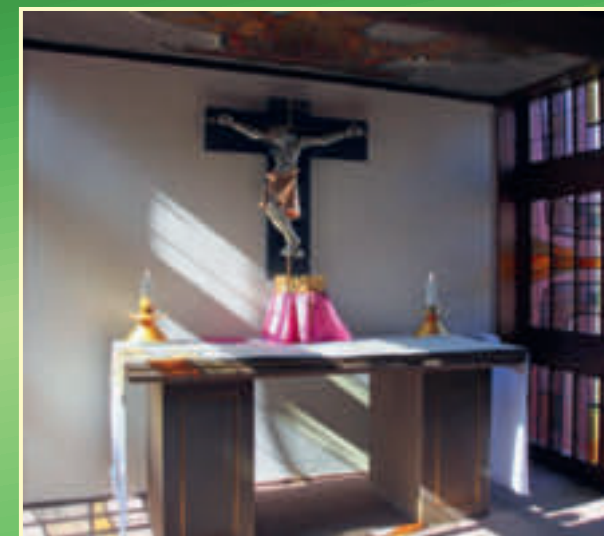
